Education & Programming Senior Manager

Oversees the entire Department of Education, staff, teaching artists, serves as line-producer on the youth "mini-legacy" productions, and collaborates directly with the Executive Operations Director and Production Manager on the overall Artistic Development of the company, manages a yearly budget of \$500,000, hires/drafts contracts for teaching artists & creative staff, prepares monthly reports for the Board Of Directors, and directs one production in the Main-Stage lineup.

Accomplishments:

- Led the company through a major fiscal, community and staffing transitional period, increasing engagement in all areas of programming and offerings.
- Represented CPA in several Executive Leader mixers, engagements, and community connection events, while working directly with patrons, donors and a CRM database.
- Introduced the "Art Of Youth Theatre Initiative" which supports a growth-centered educational approach while advancing the future direction of CPA's programming, including expanding access through the addition of a Theatre Outreach Performing in Schools (TOPS) program in Season 21, strengthening teaching quality with a required professional development retreat for summer camp artists, and providing clear instructional frameworks that balance consistency with creative flexibility.
- Created a new branch of Children's Performing Arts - "Young Professionals Summer Stock", which is a yearly rigorous, professional theatre training intensive designed for actors ages 16-25. Each summer, participants are accepted into the program via an intense audition process. Once accepted, they will engage in high-level performance training alongside industry professionals, building both their craft and career readiness with weekly one-on-one vocal coaching, specialized workshops in vocal health, self-taping, and portfolio development, dance intensives, scene study, and professional headshots.
- Introduced the "CPA Conservatory" which offers Acting, Singing and Dance lessons to the White Bear Lake, Hugo, Centerville, and North St. Paul areas, employing three teaching artists onto the roster.

BCS Summer Stock Theatre Company**May 2022 - May 2025***Artistic Director*

Coordinated season planning in collaboration with the board and departments, supporting marketing efforts and school outreach for summer youth programming. Maintained records, communications, and scheduling details. Hired and supported all creative staff and contractors. Directed seasonal productions and developed and delivered acting curriculum for the BCS Summer Acting Academy.

Accomplishments:

- Directed a total of 6 productions over the span of 3 seasons of involvement as Artistic Director.
- Grew the production and operational budget per mainstage production from \$10,000 to \$40,000.
- Strengthened community partnerships, and introduced the use of Ludus, a CRM program that is used until this day for donor tracking, and patron tickets, registration and newsletter tracking.
- Introduced the Junior production program which sees the involvement of 70 young actors on and off stage as a tuition-based educational program that runs in direct repertoire with each Main Stage production.

- Directed and produced nearly a dozen productions, including the annual Minnesota State High School league Competition One Act and contributed to Region 4AA board service.

- Led and produced 4–5 annual productions, overseeing logistics including budgeting, travel, contracts, and rentals, while hiring guest directors.
- Coordinated cross-departmental administrative efforts, advised the student guild, and taught Stage Management and Directing courses, culminating in the production of an Evening of Student Directed Plays.
